- Consumer showed some signs of recovery in September, but too early to call

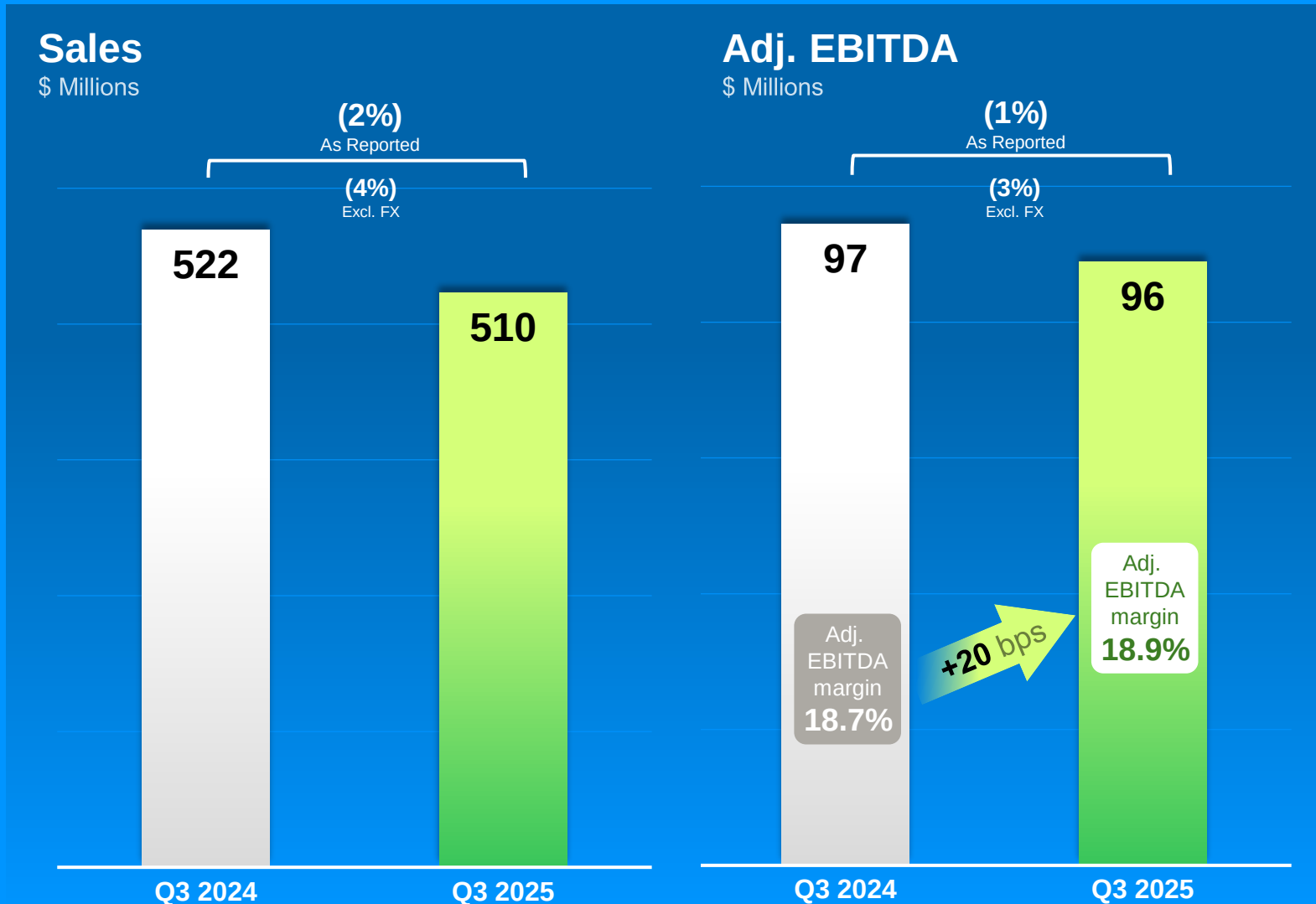
- Industrial and Building & construction remain negative; do not foresee improvement in Q4
- Energy market demand weaker than expected in Q3; influenced by delayed or paused energy projects. Expect more of the same in Q4.

Q3 growth driven by increased light vehicle production and marine applications

- Consistent strong growth in Q3 in Defense, Healthcare and Telecom markets, capturing secular trends. Expect more of the same in Q4.

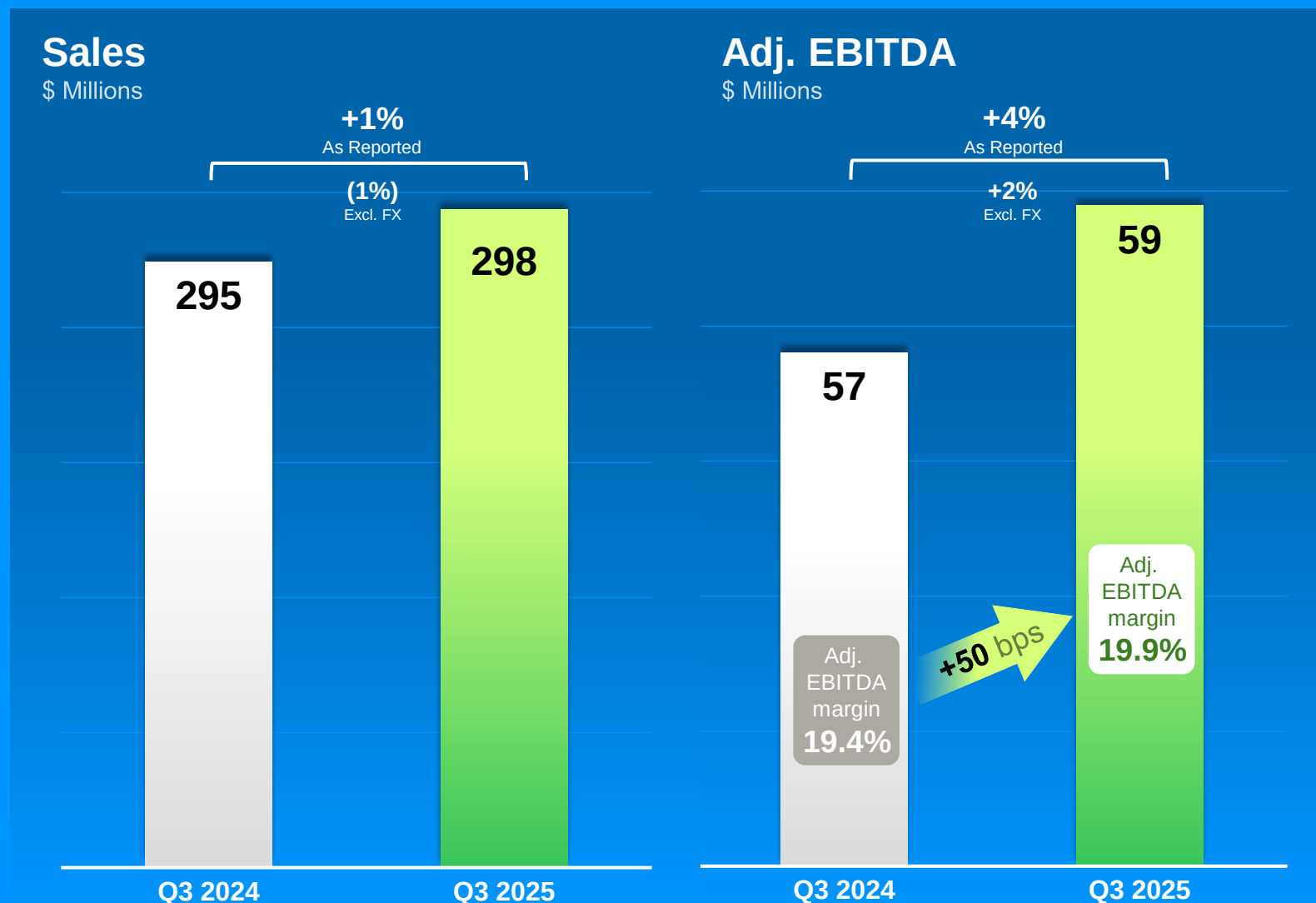
Q3 2025 results

Color, Additives & Inks – Q3 2025 performance



- Organic sales decline driven by weakness in consumer, packaging, and building & construction partially offset by growth in healthcare
- Adj. EBITDA margin expansion of 20 bps driven by favorable mix, cost reduction actions and productivity initiatives

Specialty Engineered Materials – Q3 2025 performance



- Organic sales decline driven by weakness in consumer, industrial and energy partially offset by growth in healthcare, defense and telecommunication
- Adj. EBITDA margin expansion of 50 bps driven by favorable mix and productivity initiatives

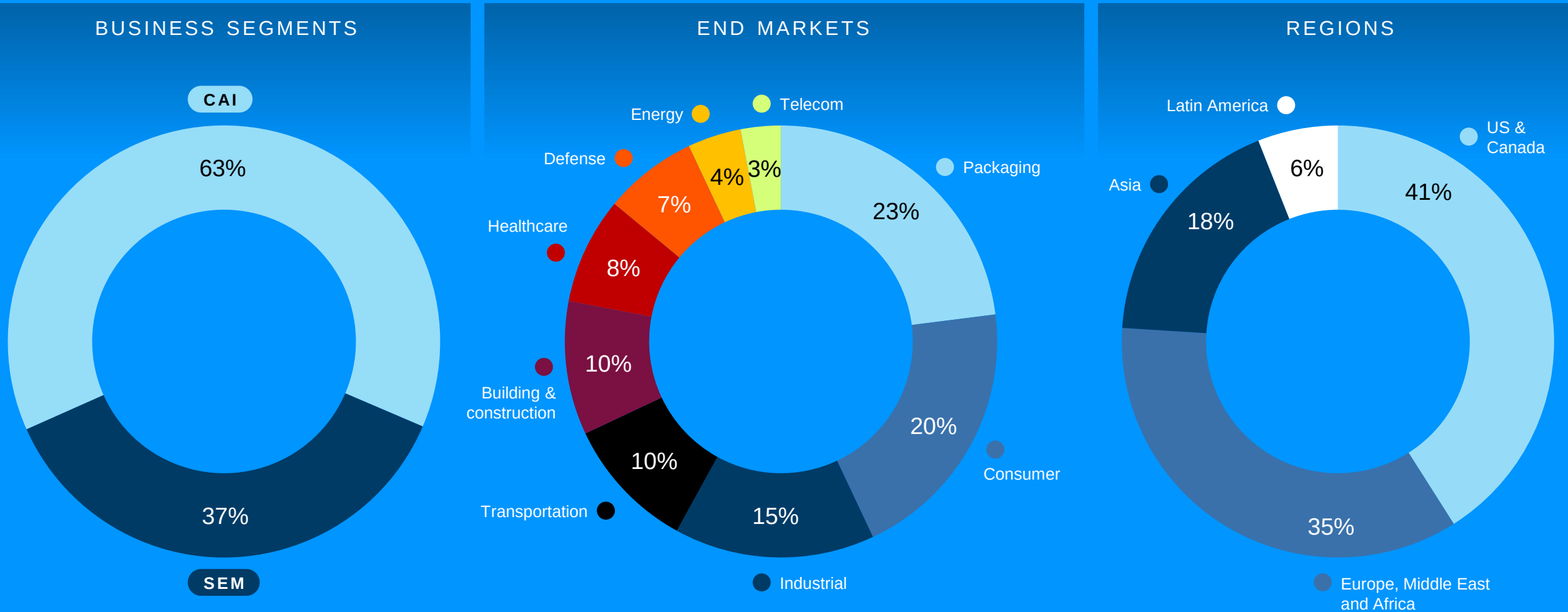

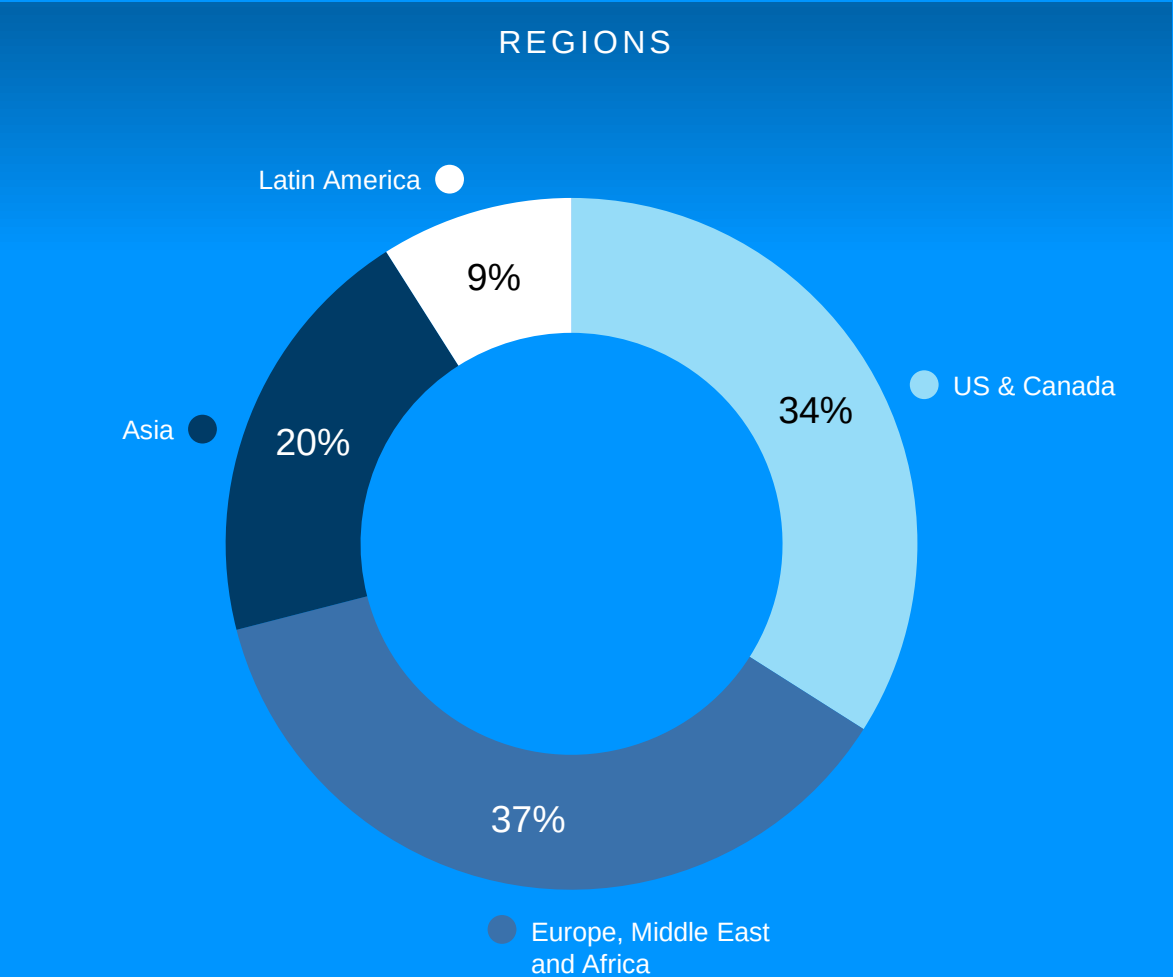
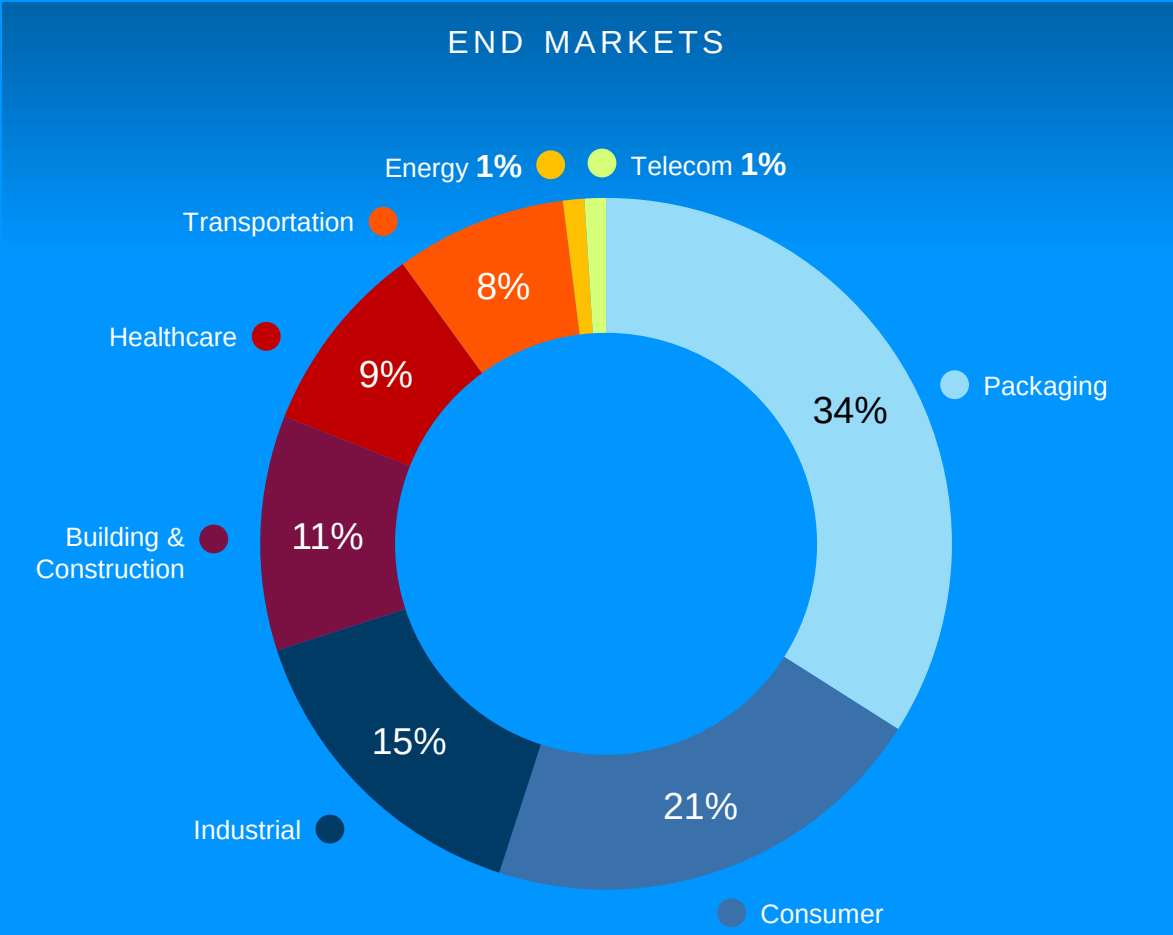
Avient 2024 sales

By business segment, by end market and by region



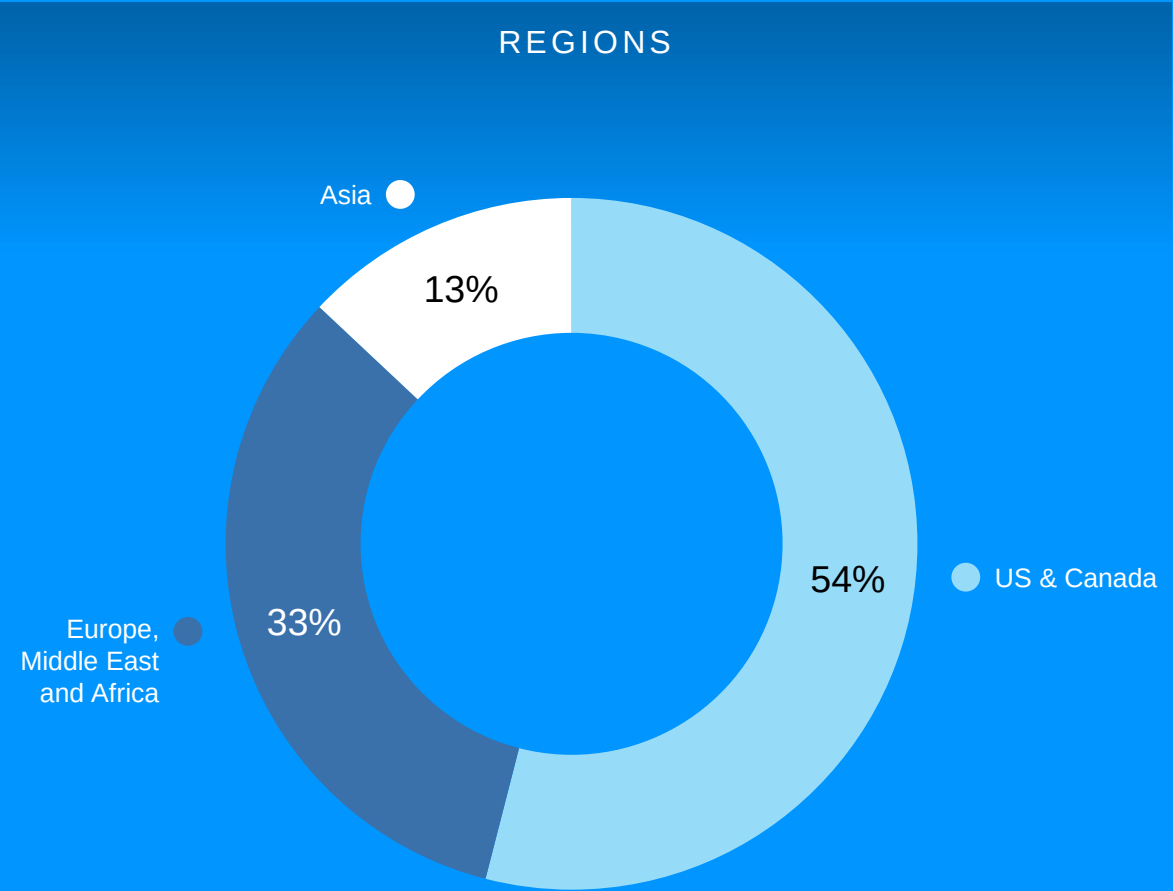
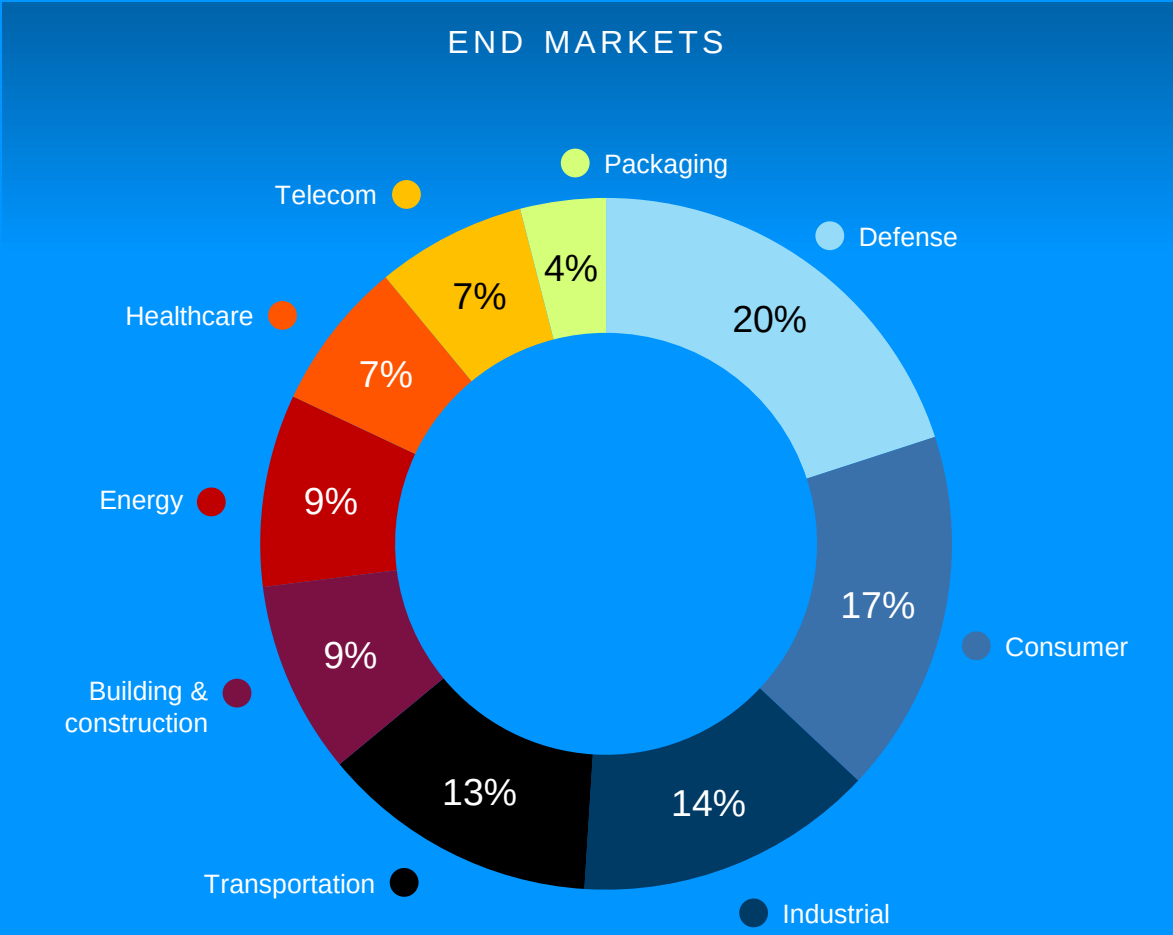

2024 revenue: \$2,047M

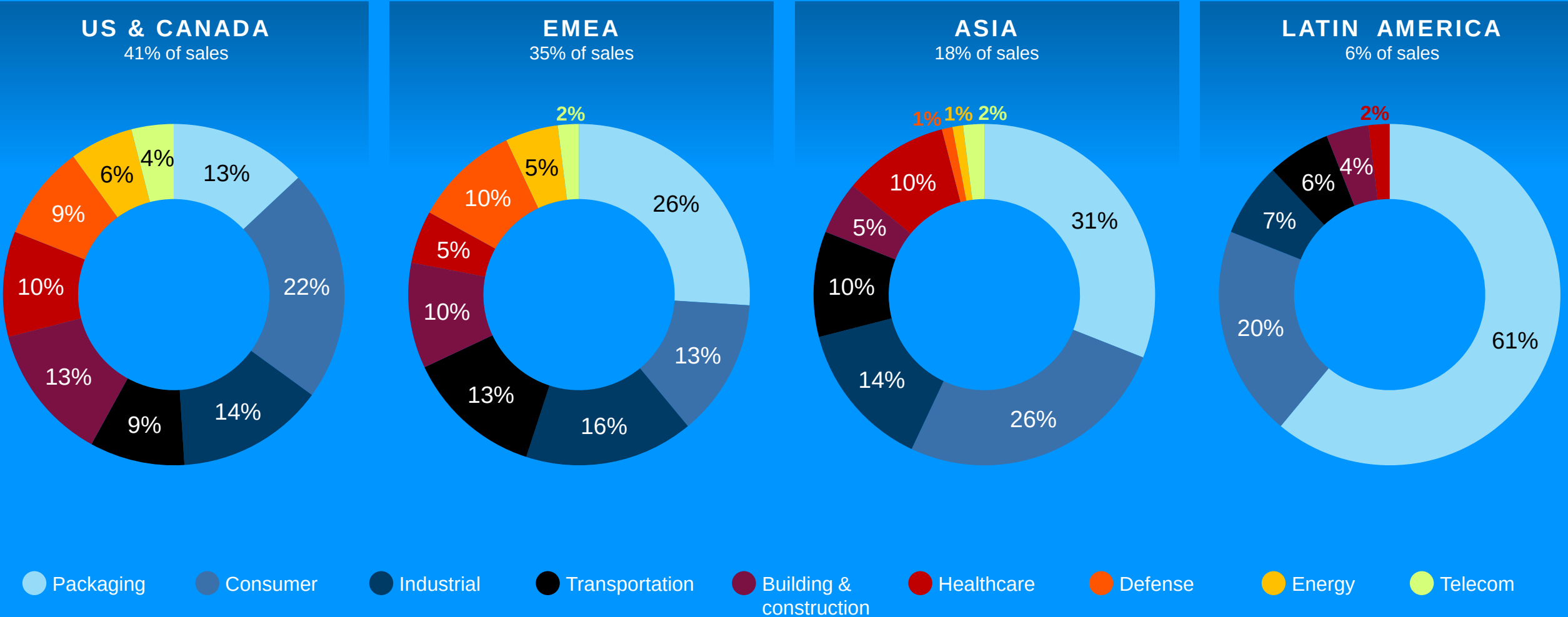


Specialty Engineered Materials

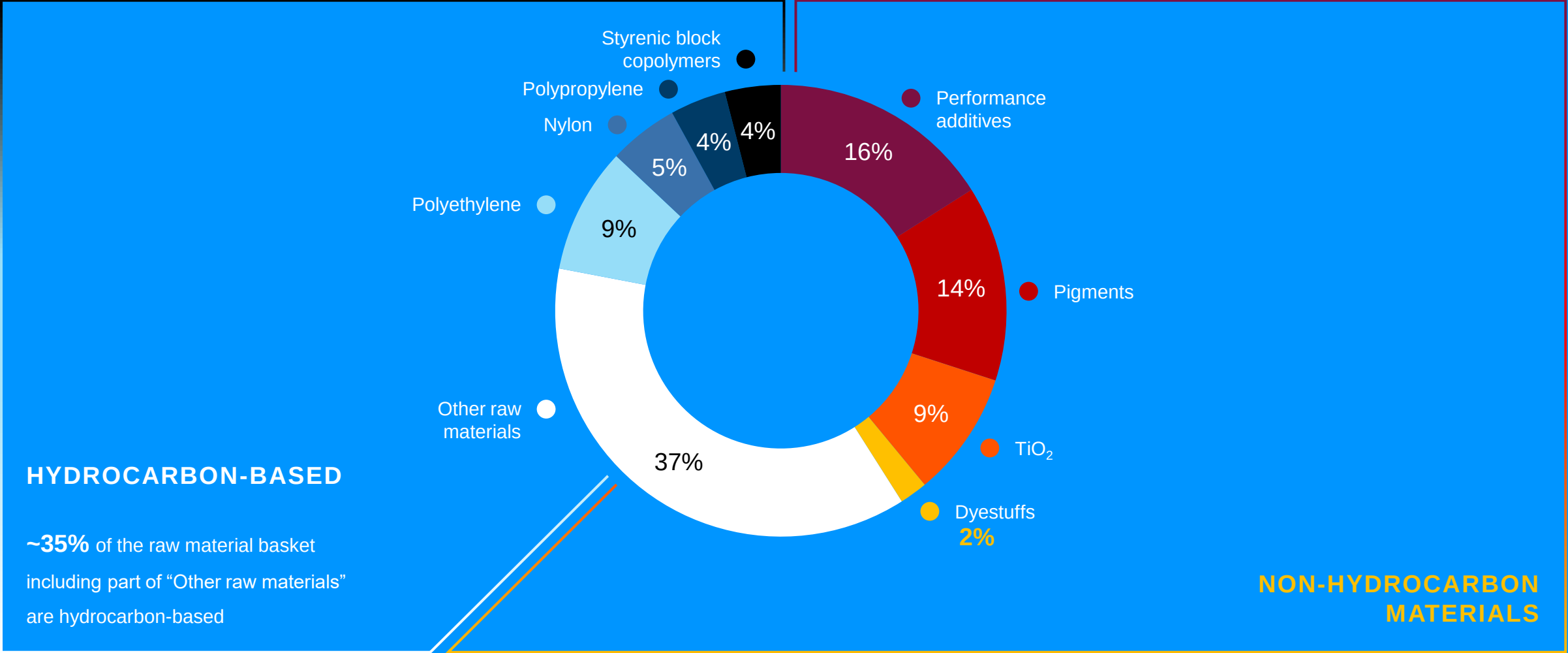
2024 revenue: \$1,197M

Senior management uses comparisons of adjusted net income attributable to Avient common shareholders and diluted adjusted earnings per share (EPS) attributable to Avient common shareholders, excluding special items, to assess performance and facilitate comparability of results. Further, as a result of Avient's strategic shift towards an innovator of materials solutions, it has completed several acquisitions and divestitures which have resulted in a significant amount of intangible asset amortization. Management excludes intangible asset amortization from adjusted EPS as it believes excluding acquired intangible asset amortization is a useful measure of current period earnings per share. Senior management believes these measures are useful to investors because they allow for comparison to

Avient's performance in prior periods without the effect of items that, by their nature, tend to obscure Avient's operating results due to the potential variability across periods based on timing, frequency and magnitude. The presentation of these non-GAAP measures is not intended to be considered in isolation from, as a substitute for, or as superior to, the financial information prepared and presented in accordance with U.S. GAAP. Non-GAAP financial measures have limitations as analytical tools and should not be considered in isolation from, or solely as alternatives to, financial measures prepared in accordance with GAAP.
